



Availability of Electronic Medical Records in CCHC Patient Portal

Patients who are registered with the CCHC Patient Portal are able to access their clinical records electronically. With limited exceptions, Test Results and Patient Visit Summary Documents are released by participating providers and hospitals within 0 to 7 days from completion¹. All test results are released to the ordering/copied providers before they are released to the CCHC Patient Portal.

1 Hospitals have different policies for autoreleasing Laboratory, Transcription, Cardiology, Gastroenterology, and Radiology results to the Patient Portal. CHOMP releases Radiology results after 3 days of delay; Lab, GI, Cardio results are released after 1 day of delay, CCD documents are released immediately; Natividad releases Laboratory and Radiology records immediately; SVMH has 7-day delay for Mammography results, other results are released after 36 hours to 3 days. CCD documents are released immediately by hospitals and providers.

2 Only providers that are releasing patient clinical records to CCHC Portal are listed in this table.

4 CCD (Consolidated Clinical Document) - patient medical records from the office visits and hospital stays include the following information: patient problem list, allergies, diagnosis, reason for visit, medication list, vital signs, immunizations, certain procedures, insurance information, caregiver information, hospital discharge instructions, plan of care instructions.

5 Natividad is releasing Patient Discharge Summaries for Inpatient and Emergency Department stays only. CHOMP and SVMH are releasing Patient Discharge Summaries for Inpatient, Emergency Department, Observation, and Outpatient One-Day Surgery visits.
